## Social Theory

### Obligatory Course within International MA in Comparative Social Research, NRU-HSE Module 2, 2014-15 Academic Year

#### ***Course description***

This course will perform two tasks. First, it will provide a basic foundation for the use of social theory for students without a strong background in theory. At the same time, the course will provide a selected set of advanced theoretical perspectives which can enrich the comparative social research modernization research field. In this way, students will be better equipped to construct research projects that communicate to other social scientists while being better prepared to defend themselves from key critiques. At the same time, students will be able to critique other comparative social research. Therefore, this course provides the foundation for later theoretical and thematic courses.

#### ***Learning plan***

Students will be reading at least one book for each lesson. For each lesson, there will also be a group of students responsible for presenting the book and broadening our understanding of it through linking it to an outside book from another major social theory ('the big three' (Durkheim, Marx, Weber), social-interactionism (Mead, Blumer), structural-functionalism (Talcott Parsons), conflict theory, etc.) Students will also serve as discussants for one lesson, where they will have a presentation and critique prepared on the main text, also broadened through knowledge of a second book. Active participation by all students is expected in every lesson. For the end of the course, students will write an essay that analyzes the strengths and weaknesses of the use of a theoretical frame within a research article.

#### ***Grading***

Participation and Attendance: students missing more than 2 lessons will be penalized. Students with perfect attendance and active participation will receive extra credit.

Presenter role: 40%

Discussant role: 20%

Theory evaluation essay (within the context of a research question): 40%

##### **Theme 1. Introduction: Provides the basic course expectations, purpose**

##### **Theme 2. The Use of Theory**

Theme two will provide a basic foundation of what social theory is, how theories are constructed, what makes a 'good theory,' and how social theory is fundamental to good empirical social research. Theory will be presented not as something abstract or irrelevant but as 'sense making.' The basic task of sociology to make sense of the social world, and theory is the language of this sense making, and is therefore fundamental to it.
