Course description:

Do you sometimes perceive that people expect certain behavior from you just because you are a woman or a man? Did you notice that in some situations men and women have different experiences?

About these and other aspects of gender we will speak during this course. We will examine the situation in various countries and investigate how gender shapes several domains of social life, including: education and employment, care and housework, marriage and family, migration, crime, health and medicine, welfare policies, and political participation. During this course you should learn to notice and to critically think about gender in various spheres of life.

Organization of the course

The course consists of 14 classes, each of which is a 2-hour module. The course materials include articles and commentary texts (to be read before the class) and TED's TALK videos, which will be watched during the class (in English, with Russian subtitles). Most of the classes assume student's presentation ("5-minute presentations") and during some of the classes I will check your knowledge of the readings with a short quiz.

Participation in the class: 10%
Final paper: 50%

Quizzes Short quizzes on the readings will be administered throughout the course. They will consist of multiple choice and short-answer questions and will cover class readings. If you have done the readings, these quizzes should not be difficult. To calculate your final grade, I will automatically drop your two lowest quiz scores and account only for the remaining, higher scores. This also means that you can be absent on a quiz twice without being penalized.

Presentation Throughout the course, you will prepare a 5-minute presentation on a specified topic. 12 of these presentations are listed in the syllabus; if the number of students is larger, the additional presentations will be added to the course. In the presentation, your task is to briefly and interestingly present a set of international data, a specific notion, or an argument. This presentation should be done on PowerPoint and should help you become more familiar with PowerPoint, help you with presentation style, and help you organize your arguments.

Paper You will be asked to write a short (5-7 pages) paper by the end of the course. Detailed instructions will be distributed in class.
