



Russian organizations were active in the first calls (122 organizations)

<u>FP6-2006-TTC-TU-Priority-3 (</u>15.02.2006 г.) has been the important call for Russian organizations


The peculiarities of this call:

For the first time Russian Government co-financed 10 successful projects with the Russian partners (the funding limit for any one proposal under this call was ~ 44,500 Euro)

Evaluation was carried out by both the European and Russian experts

5 from 17 successful projects under FP6-NMP were from Russia
