

# 1. EXECUTIVE SUMMARY:

The UNESCO Chair on Copyright, Neighboring, Cultural and Information Rights as an International Scientific and Educational Center at HSE University has become a scientific and expert center, providing HSE with forefront research on the issues of intellectual property, media law, data protection, information technologies, artificial intelligence, cultural rights and other issues of law and modern technologies. The Chair implements and promotes an integrated system of research, training, and collecting information and documentation on copyright, neighboring, cultural and information rights as well as on artificial intelligence. The Chair has a powerful team of leading

scholars united by academic interests in the sphere of intellectual property, media regulation and information technologies, economics, and philosophy. Our collaboration with other HSE departments includes teaching unique courses, organizing wide range of scientific and practical events as well as conducting expert-level legal assessment for the media industry and cultural sector. During the reporting period, the Chair has actively contributed to the development of an enabling legal environment for the protection of cultural rights and the

use of digital technologies and artificial intelligence for sustainable development by improving legal instruments in the field of cultural heritage, freedom of expression and access to information, copyright and neighboring rights, and has broadly disseminated the results of this work. We support the capacity enhancement of teachers, researchers, faculty, undergraduate and graduate students, and practitioners in our field. We have created the Chair's website, organized a number of conferences, round tables, master classes and webinars, have produced and disseminated publications including a quarterly scientific journal "Works on



Intellectual Property" and a monthly online information bulletin SREDA (MEDIUM). All this time we have been closely cooperating with UNESCO and with other UNESCO Chairs on related programs and activities.



# F) OTHER

(any other activities to report)

1. The UNESCO Chair continues publishing a quarterly scientific and analytical journal "Works on Intellectual Property".

The journal publishes scientific articles and essays, analytical materials, book reviews, expert opinions on a wide range of legal issues of intellectual property and the modern information ecosystem. Those include but are not limited to: topical issues of copyright and neighboring rights, intellectual property rights in the context of digitalization, cultural and information rights in the context of UNESCO conventions and recommendations, human rights in the digital age, legal regulation of cyberspace, mass communications, digital platforms and ecosystems, artificial intelligence and transhumanism. The journal also publishes announcements of scientific events and reviews of newly released educational literature and monographs. The journal is published on the basis of the Agreement between UNESCO and the National Research University Higher School of Economics on the establishment of the UNESCO Chair in Copyright, Neighboring, Cultural and Information Rights. It serves as a recommended journal of the Higher Attestation Commission under the Ministry of Education and Science of Russia. The journal is distributed in Russia and CIS countries.



- 2. The UNESCO Chair is often approached by the state bodies, public organizations, as well as individuals with a request to provide an official legal opinion on a particular act such as a draft law or a judicial act; or to prepare an Expert Opinion on the materials of a court case, etc. In such cases, the UNESCO Chair on Copyright, Neighboring, Cultural and Information Rights of HSE University provides a Scientific Legal Opinion based on its thorough analysis of the current Russian legislation, international legal instruments, doctrinal interpretation and law enforcement practice. When preparing such a Legal Opinion, the UNESCO Chair proceeds from the fact that the issues raised in the appeal are fully related to the scope of the scientific activities of the UNESCO Chair, as defined by the Agreement between UNESCO and HSE University on the establishment of the Chair. In preparing such a Legal Opinion, the Chair uses all the materials attached to the appeal.
- 3. During the reporting period, we have carried out the release of 15 electronic multimedia issues of the SREDA (MEDIUM) newsletter. This monthly bulletin is recommend for reading not only to lecturers, graduate students and students of the Faculty of Law and the Faculty of Communications, Media and Design at HSE University, but also to all professionals working in other educational and research centers, including related fields. Now it has near 1800 subscribers. Each month our subscribers learn about the developments that take place in media law, legislation on information,

intellectual property legislation and cultural rights. We inform our readers about the most interesting and significant news from related official bodies and the media industry. Each month the "Court Cases" section is devoted to the latest judicial practice in the protection of copyright, information, neighboring and cultural rights. The "News of Legislation and Law Enforcement Practice" section is replenished with a large number of laws and other regulatory legal acts that have been adopted and entered into force. In the "New Draft Legal Acts" section, we provide readers with our reviews of the draft laws that may soon be adopted and signed. Also each issue contains a "UNESCO News" section, where we talk about new projects and programs of UNESCO in Information, Communication and Cultural issues. Sometimes we work on this bulletin together with our interns, students of HSE University who serve as the Chair's interns or participate in the "HSE Project Fair" research project. The interns' responsibilities include selecting materials for all sections of the newsletter, editing and abstracting, and preparing the bulletin's layout. They work with legislation databases of the Russian Federation, databases of court decisions, and websites of specialized state authorities. Then they fill in all sections of the bulletin with the prepared final materials. The assistant to the Chairholder Natalya Yakimovskaya is responsible for mailing the bulletin, communicating with its readers, and maintaining the mailing lists and subscriptions.

- 4. On May 20, 2021, Chairholder of the UNESCO Chair Professor Mikhail Fedotov took part in the traditional annual advanced training courses for civil servants as a guest speaker. The courses, which have been held since 2009, were organized by the European Institute of MGIMO of the Ministry of Foreign Affairs of Russia together with the Directorate General of the Rule of Law and Human Rights of the Council of Europe. In 2021, the courses were devoted to the general topic "Implementation of International and Constitutional Guarantees of Human Rights in Russian Law and Law Enforcement Practice: 25 Years of Cooperation in the Council of Europe".
- 5. On May 25, 2021 an online meeting was held between representatives of the Russian Public Collegium for Press Complaints, the UNESCO Chair and The Interdisciplinary Research Institute Foundation Decartes, which studies the experience of media regulation in the world and, in particular, in Russia. The representative of the Foundation Léa Giffard asked a lot of questions the co-chairs of the Public Collegium for Press Complaints Mikhail Fedotov and Yury Kazakov about the work of the Collegium, the procedure for forming the chambers of the media community and the media audience, its financing, its relationship with the Unions of Journalists in Russia and Moscow, the state bodies, as well as its role in the Russian media industry. Not so long ago, a similar media regulatory body, the CDJM (Council for Journalistic Ethics and Mediation), began its work in France, which, in the course of its work, faced similar issues that had already been successfully resolved by the Russian Public Collegium for Press Complaints. On behalf of the UNESCO Chair, Natalia Yakimovskaya, Assistant to the Chairholder, told her French colleagues about the positive experience of involving students from the Faculty of Communications, Media and Design of HSE University in the work of the Public Collegium for Press Complaints.
- 6. On May 28, 2021, members of the Chair made a number of presentations at the St. Petersburg International Book Fair. The discussion was devoted to the problems of copyright in the digital age. Particular attention was paid to the prospects for legal regulation of artificial intelligence technologies. The round table was attended by Professor Mikhail Fedotov, as well as Associate Fellows of the Chair, Professor Ivan Bliznets and Research Professor of the University of Illinois Peter Maggs.
- 7. On May 31, 2021, the Associate Fellow of the UNESCO Chair, **Alexey Deineko** took part in the round table organized by the Institute of Law and Public Policy together with the National Center for Digital Economy of Lomonosov Moscow State University and the Institute for the Development of the Information Society. The round table brought together lawyers and technical scientists who discussed the issues of forming a national policy for working with data in Russia, as well as international experience in legal regulation.
- 8. On June 30, 2021, the UNESCO Chair took part in the international scientific and practical conference "Development of Information Law and Legal Informatization". It was held by All-Russian State University of Justice with the participation of the Commission of the Association of Lawyers of Russia on Information Law and Legal Informatization, the Scientific Center for Legal Information under the Ministry of Justice of the Russian Federation and with the support of the German Foundation for International Legal Cooperation under the Ministry of Justice and Consumer Protection of Germany. The purpose of the international conference was to discuss and develop current directions for the development of information law and legal informatization in the field of activity of public authorities,

- organizations and citizens in the context of the development of the digital economy in building the information society.
- 9. On July 19, 2021, **Mikhail Fedotov** joined the Working Group on Information Disputes and Other Issues of Information Support for Elections to the State Duma of the Russian Federation of the Eighth Convocation.
- 10. On August 19, 2021, the conference "History for the Future. The last months of the USSR. August 1991" was held. **Mikhail Fedotov** emphasized the crucial role of independent media in defeating the putschists.
- 11. On September 11-12, 2021, a meeting of the Commission of the Council of Judges of the Russian Federation for Relations with Government Agencies, Public Organizations and the Media was held as part of the All-Russian 2021 Forum of Modern Journalism. Professor Mikhail Fedotov in his speech has drawn attention to the problems of media coverage of high-profile litigations and highlighted the practice of dealing with information disputes by the Public Collegium for Press Complaints.
- 12. On December 9-11, 2021, the Kutafin Moscow State Law University held the III International Congress on Civil Comparative Studies "Mozolin Readings" under the title "Private Law in the Context of New Technological Challenges". Within the framework of the congress, numerous discussions took place on topical issues of civil law, the emergence of which was caused by scientific and technological development. The UNESCO Chair HSE Universitywas represented by **Elena Morgunova and Mikhail Fedotov**.
- 13. On February 3, 2022, Moscow Helsinki Group and a number of permanent commissions of the Council under the President of the Russian Federation for the Development of Civil Society and Human Rights, organised a round table concerning the prospects for changing the legislation on foreign agents. The reason for this was the corresponding draft law No. 35591-8 introduced by a group of deputies of the New People Fraction in the State Duma. Professor Mikhail Fedotov informed the participants of the discussion of this draft law with the main conclusions from the Scientific Legal Opinion of our Chair.
- 14. On February 7-8, 2022, our Chair took part in the **Distant & Digital International Educational Conference** for Experts in the Transformation of Law, Intellectual Property, Creative Industries and the Digital Economy. The Chair was represented by Doctors of Law **Ivan Bliznets**, **Elena Voinikanis**, **Victor Naumov**, **Mikhail Fedotov**, and Candidates of Law **Vitaly Kalyatin**, **Konstantin Leontiev**, **Ekaterina Chukovskaya** and others.
- 15. On February 10, 2022, a meeting was held between the UNESCO Chair and the working group of the Union of Printing Industry Enterprises (SPPI-GIPP) on the issue of improving the legal regulation of relations between print and online media publishers with digital platforms and news aggregators. Representatives of Kommersant, Rambler, RBC, and Forbes Russia attended the meeting. The working group proposed to discuss a number of measures that are supposed to minimize the so-called "technological dictate" of digital platforms over domestic media. These measures are designed to help protect the rights of media-right holders to the works they have created and to proper remuneration for their use by third parties. Also it suggests to partially compensate traditional media for the drop in market revenues from "paper" advertising and content, diversify their income and facilitate their further development. During the discussion, the meeting participants decided that it is necessary to prepare amendments to the Law "On information, information technologies and information protection", as well as to part IV of the Civil Code of the Russian Federation and, probably, to the law "On mass media". Head of the UNESCO Chair Mikhail Fedotov expressed the opinion that the amendments should consolidate the balance of interests of publishers and digital platforms. Natalia Yakimovskaya noted that information agencies and producers of audio content should be involved in the dialogue with news aggregators and search engines. Professor Ruslan Budnik asked the curator of our Chair Ms. Laurence Mayer to share European materials on the regulation of such disputes and discussed them with the working group.
- 16. On April 26, 2022, a meeting of the **Scientific Advisory Board of the Intellectual Property Rights Court of Russian Federation** was held. Many prominent experts in the field of copyright took part in the discussion, including the Chairman and the Associate Fellows of the UNESCO Chair: **Elena Voinikanis**, **Vitaliy Kalyatin**, **Mikhail Fedotov**, and **Vladimir Entin**.

17. During the reporting period, **four meetings of OSCE experts** were held, organized by the OSCE Representative on Freedom of the Media, Teresa Ribeiro. The discussions were moderated by the Senior Advisor to the **OSCE Representative on Freedom of the Media**, Associate Fellow of the Chair, Professor Andrei Richter. Other members of the Chair also took part in those meetings.

Going forward, we will continue to act in accordance with the provisions stated in Article 2 of the Chair Agreement and the **UNESCO Strategy 2022-2029**.

As a short-term development prospects the UNESCO Chair on Copyright, Neighboring, Cultural and Information Rights at HSE University continues to publish articles by Russian and international specialists and UNESCO experts in the scientific and analytical journal of the Chair "Works on Intellectual Property". We are willing to participate in all relevant UNESCO field events aiming to establish personal contacts and involve leading scientists in the field of copyright, neighboring, cultural and information rights ready to work with Russia.

As a medium-term development goal we are developing an educational program "NeuroLaw". We believe we are able to train lawyers for the neurocomputer, biotechnological and transhumanism industries. Also we are working on the creation of the program of the scientific-research seminar for students "UNESCO Norm-Setting For Sustainable Development". We will conduct it in the academic year 2022-2023, if we manage to enroll the required number of students.

As a long-term goal our Chair is going to enhance cooperation with Russian and foreign UNESCO Chairs in the context of integration into programs pursuing a set of sustainable development goals for the Russian Federation. Also we will be strengthening **cooperation with the World Intellectual Property Organization** (WIPO) in order to integrate into the global innovation ecosystem and achieve the goals of advanced scientific and technological development.

The host institution - National Research University Higher School of Economics (HSE University), funds the entire budget of the UNESCO Chair. For the reporting period, the expenses for the Chair amounted to \$162 000.

In the second half of 2021 two 2 employees of the UNESCO Chair – Ruslan Budnik and Natalia Yakimovskaya have completed an advanced training program "Creativity and Commercialization: Teaching Copyright and Legal Regulation of Means of Individualization in Higher Education and Research Institutes" in Russian State Academy of Intellectual Property at the expense of the National Research University Higher School of Economics (HSE University). The cost of training was \$3 450 per person. Upon completion of this advanced training program, both of them received an official certificate.

Premises and the **equipment of the UNESCO Chair** include: one furnished room, two computers, two landline telephones, one color printer/scanner, paper and stationery.

The expenses for the preparation and holding of two April Conferences in 2021 and 2022 were partially covered by Rospatent - the Federal Service for Intellectual Property of Russia - \$24 700.
