# **IDC** International Development Cooperation

The Ph.D. in International Development Cooperation is a multidisciplinary program with particular emphasis social, political and economic development and development cooperation. This exceptional program is dedicated to enabling graduates to develop the critical thinking, analytical research ability and professional skills required to address global development concerns including poverty, international development aid and development policies. It is therefore suitable for graduates who are committed to making an original contribution in international development either as scholars, members of leading think tanks or development practitioners.

The program is taught by a distinguished faculty with knowledge and vast experience in teaching, researching and consulting in international development with leading global organizations. Through interactive learning sessions covering various specialized professional courses, students are able to conceptualize development theories, scrutinize development challenges and generate research topics in their areas of interest.

# **Non-Degree Programs**

GSP offers various short term courses aiming to train the leaders and practitioners in international development by combining theoretical and practical content on development cooperation. The courses will broaden and deepen students' understanding of international development issues and policies through a multidisciplinary approach to identify and solve questions arising in the field of development and foreign aid. The courses will be held outside regular working hours, mainly on weekday evenings and weekends.



# Study Abroad Programs

Kyung Hee University has signed a Memorandum of Understanding with over 380 sister universities across 65 countries, including Harvard University, Keio University, Cambridge University, the University of British Columbia, and Renmin University (http://oiak.khu.ac.kr/eng/). This vast array of excellent universities provides exemplary opportunities for GSP students to study abroad, either as exchange or dual degree students.

Every year, GSP sends around 5-10 students to study abroad with generous financial support. Those participating in the exchange program or dual degree program only pay tuition to GSP and are exempt from paying tuition to the host university. Likewise, foreign exchange students wishing to study at GSP only pay tuition to their home university and are exempt from paying tuition to GSP.

### Student Exchange Program

This program allows GSP students to study abroad for one to two semesters at one of our excellent sister universities. Our partner universities include but not are limited to:

### **Eligibility**

Completion of at least one semester at GSP

- At least a 3.5 GPA and least a 850 TOEIC score or equivalent
- Students must pay tuition to GSP prior to their
- Students will be selected based on their study plan, interview evaluation, language proficiency and previous academic performance.

### Application Period

GSP sends students twice a year at the beginning of March and the begining of September. The application information may change every semester and is announced on the GSP homepage just before the process starts.

### **Dual Degree Program**

Students participating in this program can study abroad in one of GSP's sister universities for two years. The benefits of our dual degree program are that students can graduate with two M.A degrees, one from GSP and another from the partner university in just two years. Students can apply to universities that offer courses of their interest. Our partner universities include but are not limited to:

- Business Management and Social Sciences, Hochschule Osnabruck, Germany
- Public Affairs, University of Missouri-Columbia, USA
- Paris Est Creteil (UPEC), France
- School of International Studies, Renmin University, China

### **Eligibility**

- Completion of at least two semesters with at least 24 credits earned
- A GPA of at least 3.5 in the semester the application for the program is submitted
- Proficiency in the language required by the foreign university and a score of 850 or above on the TOEIC
- Permission to travel outside Korea (related to visa issuance and duration of sojourn)

### **Application Period**

The application information may change every semester and will be announced on the GSP homepage just before the process starts.

# **Graduation Requirements**

Graduation requirements vary according the student's field of study and department.

Students should be well conversant with the graduation requirements for their respective departments.

Those who are not certain about the requirements for their major should seek clarification from their department head before their final semester.

Notes: Students in either program must have a GPA above 2.7 in order to graduate. Those who earn a GPA below 2.7 for two consecutive semesters will be disqualified from the program and will not be able graduate with their M.A or Ph.D. credits earned. Korean language classes do not form part the minimum credits required for graduation.



### **Graduation Requirements for the Master's Degree Programs**

In addition to fulfilling the mandatory course requirements, M.A students must meet the conditions below to qualify for graduation:

- Submit a TOEIC score of at least 900 or equivalent (TOEFL PBT 597, CBT 247 or IBT 98; IELTS 6.5) to the administration office
- Must register at GSP for at least four (4) semesters unless they register for the early graduation program, the dual-degree program or the exchange program. Those who study abroad in the exchange program should register for at least three (3) semesters at GSP
- A GPA of 2.7 or above at the time of graduation is a mandatory requirement

### **Graduation Requirements for the Ph.D. Degree Program**

In addition to fulfilling the minimum course requirements, all Ph.D. candidates must meet the following conditions in order to qualify for graduation:

- Attain a passing grade on the Comprehensive Major Exam
- · Pass the dissertation defense
- Publish at least one paper in a journal listed on the SSCI, SCOPUS, Korea Citation Index (KCI), or journal candidates for the KCI
- Maintain a GPA of 2.7 or above at the time of graduation as a mandatory requirement

### **Early Graduation Requirements**

M.A students can graduate within three regular academic semesters. Those who are interested, and who have fulfilled the following requirements, must submit an application for early graduation in the first week of their third semester

- Students must maintain a GPA of 3.7 or higher upon application and completion of the third semester
- Students must earn 45 credits within 3 semesters
- Students must receive a TOEIC score of at least 900 or equivalent (TOEFL PBT 597, CBT 247 or IBT 98, IELTS 6.5)
- Students should have at least 36 credits from GSP coursework out of a total of 45 credits required for graduation





GSP emphasizes pragmatic learning methods and internships to provide a great opportunity to bridge the gap between theory and practice and to gain exposure to potential work environments. Through these internships, students can integrate and use their existing knowledge from classes, develop further competence through intensive field experience under educational supervision, and become better acquainted with various types of work settings. Therefore, GSP places particular emphasis on internships and especially on international experience.

All students are encouraged to undertake an internship before graduation. Students who undertake overseas internships can earn academic credits as well as receive financial aid from GSP. GSP also recognizes that obtaining internships can be a daunting task for students. Therefore, it runs a unique support program for internships called KISS (Kyung Hee International Internship Support System) which manages student internships in three stages: identification, implementation and evaluation.

### Identification

Collaborative efforts by the university, professors and students can make internship placements successful. Kyunghee University and GSP also offer respective placement programs such as the Neo-Renaissance UN/INGO Internship Program and the GSP-Washington Center Internship. Overseas internships are largely promoted via the GSP-MKE-KISS global network.





### **Evaluation for Internship Credits**


Students can earn three (3) credits for a successfully completed overseas internship that lasts for eight (8) weeks and six (6) credits for an internship of up to 16 weeks or more. To earn these credits, the student must be enrolled as a fulltime student at GSP and submit one research paper on a topic related to the internship for 3 credits or two research papers for 6 credits. Students should submit all of the required documents within 10 weeks after the completion of the internship.

During the internship, students are required to keep a journal of their activities and send them to their department chair via-email or upload them to the student blog on a weekly basis. The final internship performance is evaluated by the faculty on the basis of the daily journals, student reports, and supervisor and faculty advisors evaluations. The final evaluation is a part of the overall performance evaluation and can be used for scholarship adjustment. Students must also make a brief assessment of the internship organization. Throughout the year, GSP hosts various internship seminars where students share their experience with others.

### Financial Aid for Internship

GSP provides generous financial aid to students who are engaged in overseas internships. This financial aid ranges between either 80% of the airfare and 3 million won, whichever is lower, and is only available for students undertaking overseas internship (outside their home country). In order to benefit, students must apply for the financial aid in advance before beginning the internship. Additionally, students are only eligible for the financial assistance if they participate in internships while they are officially enrolled at GSP. Students should submit all of the required documents within five (5) weeks after the completion of the internship.








